Objectives of the conference. The main objective of the conference is to identify the specific European contributions to the UN Decade of Education for Sustainable Development and Europe's global responsibility within this endeavour. In particular, the conference intends

- to identify a common vision of education for sustainable development (ESD) within Europe on the basis of the many substantial ESD activities present in the region;
- to contribute to the understanding of ESD as a decisive element of the sustainability strategies of the European Union;
- to contribute to a better integration of ESD in European Union education programmes;
- to analyze strengths and challenges within the implementation of the UN Decade ESD thus far.

In particular, the conference will develop elements of a work agenda for the UN Decade's coming years, which can be handed on to the following EU Presidencies and that should also form the basis for the mid-term review of the Decade in 2009. In this sense, the conference additionally functions as a preparatory meeting for the mid-term review conference on the UN Decade in 2009, which Germany would be prepared to host.

Format. There will be plenary and workshop sessions. Each workshop should result in a work programme for the UN Decade of Education for Sustainable Development up to 2009. This also entails identifying deficits in implementation and examples of good practice. Each workshop therefore should be designed and carried out along the following questions:



- What is the **current situation** of ESD in Europe? Which deficits do we encounter?
- Which examples of **good practice** can we identify?
- **What is to be done** in the context of the UN Decade until 2009?

Workshops will be organized and led jointly by a German expert and an expert from another EU country.

Two conference rapporteurs will be responsible for documenting the meeting. The documentation should present workshop results in such a way as to make the publication serve as a work programme for the implementation of the UN Decade at the European level in the coming years.

Conference languages are German and English. Simultaneous translation will be offered in the plenary sessions and in some workshops. Some workshops will be conducted only in English.

An accompanying exhibition in the conference venue will present best practice in ESD.

Participants. Up to 180 participants. Each EU Member State is asked to officially nominate three experts. Additional individual experts, representatives from international organizations, and representatives from other countries and world regions will also be invited. The spectrum of participants should reflect the nature of ESD as a multi-stakeholder endeavour.

The parallel workshops should (1) analyze the state of the art, including deficits, within ESD, (2) identify good practice, and (3) elaborate a concrete work programme for the UN Decade ESD.

Workshops:

1. ESD in Europe – what are our common foundations?

The workshop should discuss the shared ethical basis for ESD in Europe. It should also take into account questions related to

sustainability as a guiding principle of the European Union and discuss, for example, the relation of the Lisbon Strategy and the renewed Strategy for Sustainable Development. A related question to consider is whether there is a specific European contribution to the concepts of sustainability and ESD.

2. Education activities and programmes of the European Union: How to increase the weight of ESD?
